

Island Jeeperz Membership Terms of Service

Last Updated: June 22, 2026

These Membership Terms of Service ("Terms" or "Agreement") constitute a legally binding agreement between you ("Member," "you," or "your") and Island Jeeperz ("Company," "we," "us," or "our"). By applying for membership, accessing our website at islandjeeperz.com, or utilizing our platform to connect with other members, you agree to be bound by these Terms.

1. INTRODUCTION

Island Jeeperz ("Company," "we," "us," or "our") operates a membership-based platform that connects individuals interested in island tours and transportation ("Traveler Members," "Tourists," or "you") with independent Jeep owners and operators ("Jeep Owner Members"). **We facilitate referrals and connections only.**

2. MEMBERSHIP TYPES & FEES

Membership is required to access the Island Jeeperz network and directory.

2.1 Membership Types

There are two types of membership on the Island Jeeperz platform:

- **Jeep Owner Membership (Paid):** Available to individuals who own a Jeep Wrangler and wish to offer tours/transportation services. Jeep Owner Members pay a recurring membership fee to maintain their listing in our directory and receive referrals. Rates and billing terms are provided at registration.
- **Tourist Membership (Free):** Available to anyone who wishes to participate in tours/rides offered by Jeep Owner Members. Tourist Membership is free of charge but is required to view listings, connect with Jeep Owner Members, and arrange tours/rides.

2.2 Payments for Services (No Platform Payments)

All fees for tours, rides, or transportation services are negotiated and paid directly between the Tourist and the Jeep Owner Member. Island Jeeperz does not collect, process, or take any percentage of these payments.

2.3 Refunds

Any paid membership fees are non-refundable except as expressly stated in our Refund Policy (if any) or as required by applicable law.

3. PLATFORM ROLE — NO BROKERAGE OR AGENCY; NO TRANSPORTATION SERVICES

Island Jeeperz is a referral and listing platform only.

- **Not a Transportation Provider:** Island Jeeperz is not a transportation provider, common carrier, tour operator, travel agency, broker, or dispatch service. We do not own, operate, or maintain any vehicles, and we do not employ drivers.
- **Services Provided by Jeep Owners:** All transportation and/or tour services are provided independently by Jeep Owner Members, not by Island Jeeperz.
- **No Contract Party:** Island Jeeperz is not a party to any agreement, understanding, or transaction between a Traveler Member and a Jeep Owner Member.
- **No Control Over Operations:** We do not set rates, routes, schedules, or any other terms of service offered by Jeep Owner Members, and we do not control how Jeep Owner Members operate.

4. INDEPENDENT ENTITIES

Each Jeep Owner Member operates as an independent business or entity.

- **No Employment or Agency Relationship:** Nothing in these Terms creates an employer-employee relationship, agency relationship, partnership, or joint venture between Island Jeeperz and any Member.
- **Member Discretion:** Jeep Owner Members retain absolute discretion regarding whether to accept a referral, whom they choose to transport, the routes taken, and the timing of their activities.
- **No Supervision:** Island Jeeperz does not control, direct, or supervise the conduct of members, the condition of vehicles, or the quality of the tours or rides provided.

5. JEEP OWNER MEMBER OBLIGATIONS

By registering as a Jeep Owner Member, you represent, warrant, and agree that you will:

- Maintain a valid driver's license, vehicle registration, and insurance as required in your jurisdiction.
- Comply with all applicable local laws, permits, rules, and licensing requirements relating to transportation, guiding, and/or tour operations.
- Use professional conduct with Traveler Members and maintain accurate, complete, and non-misleading listings.
- **Waivers:** Provide your own liability waiver for Traveler Members to sign before each tour/ride, and you are solely responsible for ensuring your waiver is legally appropriate and enforceable in your jurisdiction. Island Jeeperz may provide templates for convenience, but does not provide legal advice.

6. TRAVELER (TOURIST) MEMBER OBLIGATIONS

Traveler Members agree to:

- Sign any waiver and/or assumption of risk document presented by the selected Jeep Owner Member before participating in any tour/ride.
- Comply with all safety instructions and directions provided by the Jeep Owner Member.

- Treat Jeep Owner Members, their vehicles, and property with respect, and refrain from unsafe, disruptive, harassing, discriminatory, or illegal conduct.

7. LIMITATION OF LIABILITY; RELEASE; RISK ASSUMPTION

To the maximum extent permitted by law, Island Jeeperz shall not be liable for any injuries, damages, losses, or disputes arising from tours/rides, interactions, or arrangements made through the platform. Use of the platform is at your own risk.

- **Assumption of Risk:** Traveler Members acknowledge that off-road excursions, island tours, and vehicle transportation involve inherent risks, including but not limited to physical injury, property damage, unpredictable terrain, weather conditions, and the acts or omissions of third parties. By participating, you voluntarily assume all such risks.
- **Release of Liability:** You hereby release, waive, and discharge Island Jeeperz, its owners, officers, and employees from any and all liability, claims, demands, or causes of action arising out of or relating to any tour/ride or interaction facilitated through the platform.
- **Maximum Liability Cap:** To the maximum extent permitted by law, Island Jeeperz's total aggregate liability under these Terms shall not exceed the membership fee actually paid by you to Island Jeeperz for the then-current membership term.

8. INSURANCE

- **Jeep Owner Insurance:** Jeep Owner Members are solely responsible for maintaining appropriate commercial and/or other applicable insurance coverage for the services they provide and for verifying that their coverage extends to the activities contemplated through membership.
- **No Company Insurance:** Island Jeeperz does not provide insurance coverage for any Member and shall not be held liable for any claims arising from a Member's lack of adequate insurance.
- **Traveler Verification Encouraged:** Traveler Members are encouraged to confirm insurance coverage directly with their chosen Jeep Owner Member prior to participating.

9. CODE OF CONDUCT; TERMINATION

Members agree to act with professionalism and respect toward other members and to refrain from harassment, discrimination, or illegal activity.

- Island Jeeperz reserves the right to suspend or terminate membership immediately, without refund, for any conduct deemed detrimental to the community, including but not limited to safety violations, harassment, discrimination, fraud, or illegal activity.

10. DISPUTE RESOLUTION

- **Member-to-Member Disputes:** Any disputes arising between a Jeep Owner Member and a Traveler Member must be resolved directly between those parties. Island Jeeperz is not responsible for, and will not adjudicate, such disputes.

- **Disputes Involving Island Jeeperz; Arbitration:** Any dispute, claim, or controversy arising out of or relating to these Terms or your membership that involves Island Jeeperz shall be resolved by binding arbitration, except to the extent prohibited by applicable law. The arbitration will be administered by a recognized arbitration provider and conducted on an individual basis (not as a class), and the arbitrator shall have authority to award any relief permitted by law.

11. MERCHANDISE

Merchandise is available to all members (including both free and paid memberships). Members may purchase Island Jeeperz branded merchandise. **All merchandise sales are subject to separate terms and conditions and any applicable return/refund policy provided at the time of purchase.**

12. MODIFICATIONS TO TERMS

Island Jeeperz reserves the right to modify these Terms at any time. Members will be notified of significant changes via the email address associated with their account or through a notice on the website. Continued use of the platform following such changes constitutes acceptance of the revised Terms.

13. GOVERNING LAW AND JURISDICTION

These Terms shall be governed by and construed in accordance with the laws of the State of Georgia, USA, without regard to conflict of law principles. Any court proceedings permitted under these Terms (including to enforce an arbitration award or to seek injunctive relief) shall be brought exclusively in the state or federal courts located in Georgia, USA, and you consent to the personal jurisdiction of such courts.

14. INTELLECTUAL PROPERTY

All content on islandjeeperz.com, including logos, trademarks, and branding, is the exclusive property of Island Jeeperz. Membership does not grant any license to use Company intellectual property for commercial purposes without express written consent.

15. SEVERABILITY

If any provision of these Terms is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that the remainder of the Terms shall otherwise remain in full force and effect.
